



Mobile & Wireless M&A Trends


- There were 18 Mobile & Wireless M&A transactions in March, roughly in line with the prior month and just shy of the trailing 6 month average of 22 per month.
- YTD valuation average of 3.6x EV/Rev, is inline with broader technology M&A but remains well below the high watermark of 5.8x from 2017. Still, enterprise values remain robust with large strategic acquirers such as Salesforce, closing billion dollar plus deals.
- Deal volume in 2018 has been heavily weighted towards Mobile Apps (20); nearly doubling Adtech deal count (11) the second strongest sector by volume. In terms of value, Communication Solutions dominate spending owing to 2 major transactions (Salesforce / Mulesoft & Altran Tech / Aricent)





Mobile & Wireless Private Financing Overview

- Mobile and Wireless financing deal volume and total capital raised in March was down from the previous month and just below the trailing 6 month average. The month was off to a strong start with Instacart's \$350 million Series E Financing at a \$4.35bn valuation.
- VCs still hold record amounts of dry powder. Their eagerness to put capital to work continues to drive valuation levels and round sizes in the private market.

Mobile & Wireless Private Financings 2013-18 YTD (\$bn)








